

Your shipments to/from the United Kingdom from January 1st, 2021

**Express & Freight Solutions** would like to draw your attention to a few formalities that must be completed for shipments from/to the United Kingdom from 01/01/2021.

In order to have an export or import declaration drawn up, a (pro forma) invoice of the shipment is required. The following information must be clearly stated on this document.

- **EORI number** (Economic Operators Registration and Identification) If your company does not yet have an EORI number, you can request one via this link: <u>EORI number</u>
- Incoterm Incoterms define the buyer's or seller's responsibility for costs and liabilities in delivery. These are used to determine who is responsible for customs clearance and even duties and taxes. In general, the Incoterms DAP (Delivered at Place) and DDP (Delivered Duty Paid) are used. - **Origin** of the goods. This refers to the country where the goods were manufactured. This can have an impact on the customs duties that must be paid upon import into the United Kingdom or Belgium.
- Commodity code/HS code A commodity code or HS code is a ten-digit code for classifying products. This classification
  is used worldwide. The first six digits are internationally the same. The subdivision can be different nationally. With
  the commodity code, customs knows which products the shipment contains and how much import duties or other
  import taxes must be levied on the product. More information via these links: <u>FPS Finance Tariff browser</u> and <u>EU

- Number of items in the shipment, packaging and type (envelope/flyer/box/pallet)
- Gross and net weight It is important to indicate both gross weight and net weight.
- **Commercial value of the goods and currency** (EUR or GBP) This is the market value of the goods (to your customer). Depending on the sales conditions, the transport costs or export insurance must also be stated.

ANNEXE - Preferential origin declaration

When sending goods to and from the UK it is recommended to add a declaration of origin to your (proforma) invoice together with a detailed description of your goods.

The statement may be added in English or another language used in the EU. Preferably use the same language as used for the rest of the document.

State the place, date, name and signature of the declarant.

### Shipments with a value < 6000 EUR

# "The exporter of the products covered by this document declares that, except where otherwise clearly indicated, these products are of UK/EU preferential origin."

### Shipments with a value > 6000 EUR

For EU shipments to the UK with a value above 6000 EUR, it is required to include the exporter's REX number on the origin declaration. The REX number is the Customs Authorization Number as a registered exporter.

# "The exporter of the products covered by this document (Customs Authorisation No.\_\_\_\_\_) declares that, except where otherwise clearly indicated, these products are of UK/EU preferential origin."
